### REVISED SCHOOL CODE ("CODE") PROVISIONS

## I. PROVISIONS APPLICABLE TO PUBLIC SCHOOL ACADEMIES BY REFERENCE IN THE CODE OR THE STATE SCHOOL AID ACT

MCL 380.504a(g) provides that public school academies may borrow money and issue bonds in accordance with section 1351a, "except that the borrowing of money and issuance of bonds by a public school academy is not subject to section 1351a(4) or section 1351(2) to (4)."
